IMPORTANT INFORMATION FOR APPLICANT

- Acceptance of this application is subject to the following conditions:
1. The YOM plates described on the application must be authentic and serviceable as determined by the Department of Motor Vehicles (DMV).
 2. The YOM plate number cannot conflict with any license plate series still in use, regardless of type OR carry connotations offensive to good taste and decency. The license plate must be a 1962 issue or older.
 3. The vehicle to which the YOM plates are assigned must be a 1962 or older model vehicle and currently registered in California.
 4. The YOM license number is subject to approval by the DMV Headquarters Special Processing Unit.
 5. If you wish to retain YOM plates that will not be assigned to a vehicle or are assigned to a vehicle with expired registration, a \$20 retention fee is due each year at the expiration of the registration year of the vehicle to which the YOM plates were last assigned. If the annual retention fee is not paid, the plate number will be made available to someone else.
